#### Involvement Process for the SPSA and Annual Review and Update

Pivot Charter School is focused on ensuring high levels of student engagement, academic growth and implementing an educational program where students "learn more and struggle less". Each year parent and student surveys are conducted and the information from those surveys is aggregated and analyzed. However, in the last 12 months Pivot distributed four surveys to families regarding students' well being, access to technology, access to academic support and barriers students faced at school. These surveys were analyzed and immediate steps were taken to ensure students received the support they needed. In addition to the surveys distributed to all Pivot families, a specific survey was provided to students of low socioeconomic status regarding their specific needs and the challenges to accessing education and academic support that they may have faced. Ongoing feedback was provided to the school as teachers met with individual students twice a week to discuss the student's educational plan and measures the school could take to support their success. Monthly meetings were also held with the parents/guardians and the student so families had the opportunity to discuss the students' progress and the needs of their students. Monthly staff meetings were held to discuss how to ensure students are engaged in learning and how to support the students' social and emotional well being. In addition to the monthly all staff meetings, the administrative team analyzed the needs of all of the students from the following data sources: diagnostic assessments (which students take three times a year), credits, graduation rates, attendance, time spent in instruction, and the number of students on the Multi Tiered System of Support. In addition, the Governing Board of the school was informed about student performance in monthly updates. Due to the unique nature of the current times, similar ongoing (more than annual) measures will be implemented to ensure continued review of student learning throughout the coming year in relation to the goals set forth in this plan.

Pivot's certificated staff person serving as the Multi Tiered System of Support (MTSS) Coordinator focuses on individualized student needs. They work with teaching staff to provide additional supports and strategize how best to help each student succeed focusing on their individual circumstances and academic backgrounds. With the teacher, the MTSS coordinator will use multiple data points to analyze where students' needs are greatest and develop an individual academic plan for the student. The MTSS coordinator can focus on breaking down the barriers that students who are socioeconomically disadvantaged face.

The MTSS coordinator will develop more extensive targeted professional development for all school staff focusing on recognizing the barriers low socioeconomic students face and how to utilize our curriculum and technology to overcome those barriers.

The MTSS coordinator will participate in professional development focused on alternative strategies for engaging students who are socio economically disadvantaged.

The school will review policies, procedures, curriculum and technological resources to ensure that students who are socioeconomically disadvantaged are able to access a strong educational program and additional supports as outlined in the Student Support Team Plans.

Students will participate in weekly I-Ready and Exact Path remediation curriculum based on their diagnostics as outlined in the students MTSS Student Support Team Plan developed by the MTSS coordinator and teaching staff.

The LEA shall partner with stakeholders (including principals and other school leaders, teachers, and parents) to locally develop and implement the CSI plan for the school to improve student outcomes, and specifically address the metrics that led to eligibility for CSI (Stakeholder Involvement).

#### The CSI plan shall:

- 1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable);
- Include evidence-based interventions (Strategies/Activities, Annual Review and Update, as applicable) (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" at <a href="https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseinvestment.pdf">https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseinvestment.pdf</a>);
- 3. Be based on a school-level needs assessment (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- 4. Identify resource inequities, which may include a review of LEA- and school-level budgeting, to be addressed through implementation of the CSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities; and Annual Review and Update, as applicable).

## **Targeted Support and Improvement**

In partnership with stakeholders (including principals and other school leaders, teachers, and parents) the school shall develop and implement a school-level TSI plan to improve student outcomes for each subgroup of students that was the subject of identification (Stakeholder Involvement).

#### The TSI plan shall:

- Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- 2. Include evidence-based interventions (Planned Strategies/Activities, Annual Review and Update, as applicable). ## Additional Targeted Support and Improvement

A school identified for ATSI shall:

 Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

## Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
